- 1. Three terms are offered in one academic year. Tuition Fees and Tech Fees are to be paid before the commencement of each term.
- 2. The above fees do not include school uniforms, books, meals, personal insurance, certain specialised after-school activities, and field trips, which will be invoiced separately.
- 3. The supplementary English Intensive Programme+ (EIP+) or English Immersion Programme (EIP) fee is charged for learners who require intensive English language support beyond that which can be provided as part of our standard mainstream and/or EAL curricula. Enrolment into the EIP+ or EIP will be determined as part of the Admissions Process. Places are limited. Below are the supplementary charges incurred:
 - Lower Primary English Intensive Programme+ (Year 1 to 3) RM5,000 / term
 - Upper Primary English Immersion Programme (Year 4 to 6) RM2,500 / term
 - Lower Secondary English Immersion Programme (Year 7 to 9) RM3,000 / term
- 4. It is mandatory for students who are enrolled in Year 6 and Year 9 to register for Cambridge Checkpoint exams. The exam fees in Year 2024 are **RM700** and **RM850** respectively, and subject to annual increase.
- 5. Late payment charges of two per cent (2%) per month will be levied, which is calculated on a daily basis from the payment due date.
- 6. All external exam fees are borne by students.
- 7. The deposit is refundable, subject to compliance with the Withdrawal Policy. The deposit and all fees paid upon confirmation of enrolment will not be refunded or shall not be transferable if the Student does not attend School thereafter after being confirmed an admission. This security deposit shall be forfeited if the admission is not taken up.
- 8. Fees are subject to yearly increases. UCSI International School reserves the right to review its fees without prior notice.
